PROPERTY RELATIONS AS OBJECTS OF STATE SUPERVISION (CONTROL) FOR LABOR PROTECTION IN ENTERPRISES, INSTITUTIONS, ORGANIZATIONS OF AGROINDUSTRIAL PRODUCTION

Property relations are considered and analysed during realization of state supervision after a labour protection in agriculture, investigational place of the State inspection of agriculture of Ukraine, it territorial organs in these relations, conducted analysis of current legislation.

State supervision (control) in agriculture of Ukraine, State inspection of agriculture of Ukraine, it territorial organs, labour protection.

According to Art. 43 of the Constitution of Ukraine everyone has the right to work, which includes the opportunity to gain his living by work which he freely chooses or freely agrees. Under conditions of high dynamics of modern Ukrainian, variability socio-economic situation of the labor problems are becoming more complex character. Complicated production processes, performance needs of employees new skills, and employers - to increase production efficiency. The most keenly felt problem of labor - a constitutionally guaranteed the right of everyone in Ukraine.

Regulation of relations between employer and employee on security issues, of occupational health and working environment and the establishment of a single order of safety of work in Ukraine carried under the Constitution of Ukraine together with the relevant government authorities, including, in accordance with Section IV of the Law of Ukraine "On Labour Protection" (hereinafter - the Law), The Cabinet of Ministers of Ukraine, central executive authority for occupational safety (State Service of Mining Supervision and Safety of Ukraine); ministries and other central executive authorities (including the Ministry of Social Policy of Ukraine and the Ministry of Health of Ukraine); Council of Ministers of Crimea, local state administrations and local authorities within their powers.

The legislation of Ukraine included the rules of the Convention on the establishment of inspection in agriculture, but does not include some of the positions of the inspection tasks such as ensuring the application legal provisions relating to conditions of work and protection of workers during their work, such as provisions relating to hours, wages wages, weekly rest and holidays, safety, health and welfare, the employment of women, children and adolescents, and other matters, to the extent that labor inspectors ensure the application of these rules is pretty important, and clearly gives the right to agriculture inspectors conduct inspections and enterprises subordinated to other central bodies of executive power in agriculture, for example, the State veterinary Medicine of Ukraine and the State Land Agency of Ukraine.

Law of Ukraine "On Basic Principles of State Supervision (Control) of economic activity" contradicts the norms of the Convention in part prevention owners or authorized bodies to carry out inspections and frequency of inspections in the field of labor. Specified gives the right inspectors to apply labor protection rules of the Convention.

The rules of the Convention entitle employees of the State Agricultural Inspectorate, the powers which include audits of compliance with legislation on occupational safety have the status of civil servants.
