

## **SOME QUESTIONS OF LEGAL REGULATION OF TRAINING AND LABOUR MARKET IN AGRICULTURAL SECTOR OF UKRAINE**

*The work investigates the features of legal regulation of training and the labor market in the agricultural sector of Ukraine. Noted that the current legislation in the field of regulation of relations training and the labor market is not fully reflect the specificity of training and the labor market is in the agrarian sector of Ukraine requires improvements and additions to enhance the effectiveness of legal regulation of these relations, the preservation and development of labor potential of the country in whole.*

Development of Agricultural Education is an important link in the innovative development of the agricultural sector of Ukraine. Agricultural education is a source of replenishment personnel of the agricultural sector and provides population engaged in agricultural production with modern knowledge necessary for economic development of any country.

The initial element of social village with its revival and development is organizational and legal specialist training in trades necessary for the agricultural sector of our country. It is known that agrarian and land reform belongs to defining nation in Ukraine, ensuring its food security and therefore act as a reliable staffing highly skilled experts of agriculture can not be overemphasized.

Cabinet of Ministers of Ukraine resolution «On approval of the State Target Program of Ukrainian village until 2015» states that the most acute problems in rural areas is the lack of motivation to work, poverty, migration, unemployment, lack of social infrastructure and deepening demographic crisis dying villages.

The average wage in agriculture is the lowest compared to other sectors. Gaining alarming rate reduction demographic and labor-reproductive potential of the village. Decreased levels of rural employment.

To date, research into the problems of legal regulation of training and the labor market in the agricultural sector of Ukraine is in the early stage of its development. Despite the fairly extensive coverage of some problems of this area scientists, many questions were investigated fragmented and require more detailed investigation.

Analysis of research and publications recently shows that the issue of training and the labor market, employment and labor market regulation in the agricultural sector of our country are considered largely in the writings of economists

The analysis leads to the conclusion that the main means of productive rural employment should be considered: improving the system of vocational training and retraining of unemployed labor villagers; providing state support for small and medium enterprises in rural areas; creation of a special fund to support entrepreneurship in rural areas for young families; improving the conditions of implementation peasants production of private farms; encourage the development of farms and other enterprises engaged in agriculture on a professional basis and using modern industrial technologies; development of annual employment programs; development of a mechanism for evaluating the effectiveness of vacancies in terms of their potential attractiveness and ability in the near future to provide productive employment.
