ON THE MANUSCRIPT OF MONOGRAPH Y.V. DELIA "RULEMAKING OF PUBLIC ADMINISTRATION: PROBLEMS OF THEORY AND PRACTICE OF IMPLEMENTATION"

Manuscript of monograph Y.V. Delia "Rulemaking of public administration: problems of theory and practice of implementation" devoted to scientific subjects, which is one of the most relevant in terms of the theory and practical activities of state and local governments. The author convincingly argues that integral feature of democratization of society, providing efficiency of social management and development of the state, is the public administration.

Development of legal, democratic state with a socially oriented market economy, actively operating institutions of public governance and management today is an important task, which came to Ukraine. Addressing these issues depends on various historical, political, economic and social factors, overcome which requires legal safeguards and regulation implementation of the rule-making subjects of public administration. Undoubtedly, these activities should take place within the Constitution and laws of Ukraine. The development of national state and law has to modern legal science complex tasks on the effectiveness and timeliness of the solution of which depends the future of Ukrainian people and Ukrainian civil society as a whole. Their content consists primarily in a proper and timely theoretical and methodological support of administrative rule-making and enforcement processes.

Today, the concept of "public administration" is quite common in legal acts of Ukraine and the writings of some scholars, but, unfortunately, modern science is not formed a unified approach to the definition of this concept, also rulemaking activity of subjects of public administration. The above fact indicates the need to deepen the research concept of public administration, its nature and especially its impact on society in the specific circumstances of modern Ukraine.

The realities of today put forward specific requirements for activity of subjects of public administration as part of public authorities. Therefore, it is essential that the activities of public administration was built on democratic principles. The recognition in the Constitution of Ukraine and laws of basic principles of public administration in Ukraine, the experience of its implementation for almost twenty years period necessitates fuller use of the possibilities this institution. Problems of Public Administration investigates by the global legal science a relatively long time, but scientific interest in this issue not reduced.

Y.V. Delia quite understandably points out that special influence have legal provisions that are contained in the Constitution of Ukraine: recognition and guarantee of public administration, the right of citizens to participate in public affairs, in national and local referendums, free elections and the opportunity to be elected to public authorities and local governments use the equal right of access to public services. Due to actions of law can see ways of development and finding new forms of regulation of public administration in Ukraine, improving the field of domestic law in general.

On these grounds the author concludes that the largest source of law in Ukraine in the field of public administration in recent years has changed both quantitatively and qualitatively. As a result of the study made a number of constructive proposals and made a number of original conceptual positions in the field of public administration.

Successful structural construction, consistency and validity of conclusions indicates that the author managed to achieve the goal, which came into precise and detailed form at solving the main problems and proposed ways and suggestions. Conclusions and recommendations outlined in the monograph are based on the results of relevant research.
