

## **SUBJECTS OF ADMINISTRATIVE OFFENCES DURING THE PERFORMANCE OF PUBLIC-SERVICE ACTIVITIES IN THE AGRICULTURAL SECTOR OF UKRAINE**

*The structure of subjects of administrative offences in the implementation of public-service activities in the agricultural sector of Ukraine is revealed. In the paper their characteristics and peculiarities of their administrative responsibilities are determined.*

***Subject of administrative offenses, administrative responsibility, officials, authorities, no government agencies, entities providing public services, control activities, the agricultural sector of Ukraine.***

The subjects of public services in the agricultural sector of Ukraine is the state bodies (their officials), local governments (their officials) and , ***no government agencies***. In case of failure or inadequate providing public services in the agricultural sector, if these actions have elements of an administrative offense and subject to other grounds of administrative responsibility, entities providing public services can acquire the feature of administrative offenses.

The purpose of this paper is to define the subjects of administrative offenses during the public-service activities in the agricultural sector of Ukraine, their characteristics and features of administrative responsibility.

First, we note that the study of subjects of administrative violations in the implementation of public-service activities in the agricultural sector of Ukraine requires the definition of what constitutes "an administrative

offense." Incidentally, we note that the current legislation of Ukraine does not contain specific legal rules that would identify the concept of the subject of an administrative offense, or which at least are listed the main features of the subject of an administrative offense.

In the paper we prove that the subjects of administrative offences in the implementation of public-service activities in the agricultural sector of Ukraine may be a special individual subjects who have common and specific features. Established that they can be officers of authorities (government and local governments), officials of non-governmental organizations ( legal entities of public services which is one of the areas or main activity) and individual entrepreneurs engaged in activities the provision of public services.

The characteristics of administrative responsibility of officials of non-governmental agencies or individual entrepreneurs as providers of public services in the agricultural sector of Ukraine, leads to the conclusion that the subjective aspect of the liability is the responsibility of entities subject to administrative coercion by deprivation of personal, property or organizational nature for administrative offenses committed by them relating to the violation of the established rules on the procedure for the provision of public services to the subjects of the agricultural sector of Ukraine. It, may be due to exercise control and supervision in the order provision of public services by public bodies and local authorities to ensure full and comprehensive public interest entities meet the agricultural sector of Ukraine

The analysis allowed to conclude that the officers of power structures perform control and supervisory jurisdiction over the activities of non-governmental entities and individual entrepreneurs with the provision of public services
