A KEY TO THE CONSOLIDATION OF SOCIETY**

In the article subjected to study theoretical and practical issues approved by the Institute of Public Administration in Ukraine. Analyzing theoretical sources attempt to examine the role and importance of the institution in the life of Ukrainian society and to identify the factors that influence its development, and ways to improve the management model of the field.

The actual task that now faces the Ukrainian society is the development of legal, democratic state with a socially oriented market economy, vibrant institutions of public power and control. The solution of these questions depends on various historical, political, economic, social factors, the overcoming of which requires legal safeguards and regulation of the implementation of standard-setting entities of public administration. Of course, such activity must occur within the framework of the Constitution and laws of Ukraine. The development of the national state and law confronts modern legal science complex tasks, the effectiveness and timeliness of decisions, which affect the future of human, civil society, and

the Ukrainian state as a whole, their content is primarily in the proper and timely theoretical and methodological provision of the constitutional law making and enforcement processes. As the representative of the public authorities and legal viability of the subjects of public administration, Institute of public administration is one of the priority places.

The theoretical basis of the research Institute for public administration as an integral element of the consolidation of civil society, legal state is represented in the works of outstanding scientists. However, despite the fact that for a long time the study of the basic principles of the functioning of local government, as part of public authorities in Ukraine was and remains a subject of special attention of experts in the field of constitutional and administrative law. Today, the question of defining the role of public administration can hardly be regarded as sufficiently justified because of the presence of significant differences in the approaches of scientists to clarify certain aspects of its operations. One of these poorly studied issues can be considered as defining the role of the Institute of public self-government as an inherent attribute of the democratization of society, and, in particular, its consolidation.

Thus, **the aim** of the article is the study of the role of the Institute of public administration as a factor of consolidation of Ukrainian society. One of the main objectives of our work is to create scientific-theoretical bases of the Institute of public administration in Ukraine as a guarantee of the unity of society and coverage framework, which is adjustable relationship in the Institute.

To achieve this objective is solved certain problems: - analyzed existing research works and the status of current legislation in the context of the subject;- developed proposals to improve the regulatory legal acts of Ukraine in the sphere of public administration.

The practical significance of the results lies in the fact that the provisions and conclusions of the article to expand the space for further

theoretical study of problems of development of public administration in legal science.

In part, the impact of the Institute of public administration on the state of consolidation of the society, it should be noted that certain features in common statutes of territorial communities could be found in the charters of other non-governmental entities that operate in Ukraine. As an example, such provisions are enshrined in the Laws of Ukraine "On Association of citizens" (1992) and "On political parties in Ukraine" (2001). In the charters of political parties among the objectives are: improvement of the political system of Ukraine, implementation of the principles of direct accountability of government to citizens, civil society development, democracy; decentralization of state power, local self-government and self-organization of the population; the consolidation of society on the basis of universal values, upholding the priority of the natural rights and freedoms, etc. Thus, the problems of democratization of Ukrainian society is not indifferent state institutions, no public education, because it is quite natural that the efficient solution of issues of local importance depends on the goal of creating things that are United by common interests, values and goals of society.
