ANALYSIS OF MODERN furniture and woodworking industry UKRAINE

A feasibility study facilities for the production of furniture and wood products in Ukraine. The effect of export-import operations in the state of Ukraine's domestic market. Proposed measures to implement the existing potential furniture and woodworking industry.

Power, furniture, wood, export, import, measures potential.

In the analysis of economic growth in the global market leaders often overlooked that one of the main factors of market expansion is a powerful lisoderevoobrobna industry. Currently, according to the UN, the volume of world trade in forest products is over 1trl. \$, Is projected to continue its steady growth. The most important prerequisites for the development of woodworking industry of Ukraine is the availability of domestic raw materials and powerful woodworking enterprises. So for the rational use of required analysis and development of measures to stimulate production.

The purpose of research- Identify the factors which influence the technical and economic potential of woodworking industry of Ukraine and to develop measures to stimulate domestic production and consumption of wood products.

Methods of research. In theykorystani economic and statistical methods of data analysis companies and the State Statistics Committee of Ukraine.

Results. Industrial output sold in 2012 for activity "Manufacture of wood and of products of wood, except furniture" made 8.204 billion. UAH., Or about 1 billion. Dollars. US, representing 0.8% of total industrial production in Ukraine. The export activity on "Treatment of wood and wood products, except furniture" made 1.06 billion. Dollars. USA, which is 1.6% less than in 2011. At the same time a decrease was observed in imports since last year for activity "Manufacture of wood and of products of wood, except furniture» Ukraine imported products 349 3 mln. USD. USA, which is 6% less than in 2011. Volume production, exports and imports of wood and wood products in Ukraine are given in Table. 1.

Enterprises association in 2012 produced 1629 thousand. Cubic meters. derevynnostruzhkovyh plates, of which 1085.4 thousand. cubic meters. laminated. At the same time there was a small decline in output, compared to the previous year growth rate of 98% and 94%.

Leaders for the production of slabs is derevynnostruzhkovyh company "Svispan-Limited" and of "LC Interplit Nadvornaya" in accordance with volumes 313.5 thousand. Cubic meters. and 197 thousand. cubic meters.

Good performance development of new facilities demonstrates LLC "Kronospan UA" which has produced 180.4 thousand. Cubic meters. derevynnostruzhkovyh plates. Fibreboards small thicknesses produced two powerful woodworking plants, namely "Uniplyt" Ltd 18.5 million. Square meters. and JSC "Fanplit" 7.8 million. square meters. In fibreboard also experienced a decline, compared with the previous year growth rate skly 97% and 67%. Total production FFS in 2012 was 26.3 million. Square meters. growth rate of 85.7% by 2011.

Plywood is made in Ukraine five companies of the association members. In 2012 the production of plywood was 167 thousand. Cubic meters. or 98.8% of the previous year. The leader is LLC "ODEK" Ukraine 79.1 thousand. Cubic m., Or 47.4% of total production.

The volume of sales in 2012, according to the type of "furniture" made 5.79 billion. USD, or about 720 mln. USD. US, representing 0.5% of total industrial production in Ukraine. The export activity for the "Furniture" was 508.77 million. Dollars. USA, which is 14.1% higher than in 2011. At the same time a significant rate increased imports of furniture, so last year Ukraine imported furniture products to 550.1 million. Dollars. That is by 13.6% more than in 2011. Volume production, export and import of furniture in Ukraine are given in Table. 2.

From these figures shows that foreign economic trade balance positive in woodworking and furniture industry in the negative. That market furniture Ukraine imports half occupied. This certainly decrease the internal market and plate materials.

Given the situation prevailing in the industry and create appropriate conditions for existing potential of the forestry industry Ukraine offer:

1. Recognize the woodworking and furniture industry priority areas of Ukraine;

2. Develop and implement a mechanism for the implementation of untreated wood for large enterprises under long-term contracts for a period of 1 to 10 years;

3. Primarily ensure domestic production of untreated timber, and export it to carry on the residual principle;

4. Limit the growth of imports of furniture and plates by introducing import duties and derevynnostruzhkovi fibreboards, plywood, 7%, and furniture 10%;

5. Reduce or abolish the import duty on hardware for furniture and melamine, are not produced in Ukraine and imported for domestic production;

6. Establish a system of deeply processing of wood. For ts`oho at the state level to encourage the practice of collecting and processing of wood and introduce policies to encourage the creation of a system of concentration and specialization sawmill production in order to maximize the use of wood;

7. Recommend the furniture manufacturers buy most of plate products from domestic producers and encourage the purchase of furniture Ukrainian producers. To recommend this for public funds to buy furniture exclusively Ukrainian producers;

8. Develop and implement mechanisms for tariff protection of the domestic furniture market, derevynnostruzhkovyh and fibreboards and plywood. To implement this Technical Regulation on Security of furniture that defines the technical requirements for manufacturers, conformity assessment procedures and content of labeling;

9. Establish a mechanism in which the clearance furniture importers should be submitted documents for compliance with sanitary and phytosanitary standards, national standards Ukraine for each consignment furniture, boards and wood products that are imported in Ukraine;

10. Development Program lisoderevoobrobnoyi industry by 2025;

11. Adopt policies to encourage the activities of national and wood furniture exporters;

12. to extend the transitional provisions of the Tax Code for 3 years - until January 1, 2017 on action benefits VAT on the supply operation, import and export of unprocessed timber headings 4401, 4403, 4404 according to UKTZED.

It is important to note that the implementation of the proposals listed above will increase the production volume by 30-50%, provide a fully domestic demand and further recycle 2 million. Cubic meters of untreated wood.

NEW EFFICIENT EQUIPMENT FOR PROCESSING Wooden pallets

Studied precision cutting wooden pallets on specially created automated line.

Wood pallets, pallet processing line, precision and quality.

Today transportation of products, of handling and its storage spend mostly using wooden pallets. The quality of work depends on the precision manufacturing pallets and their processing (marking, cut corners and lower milling boards).

Choosing the right pallet will effectively carry products perform loading and unloading operations and store to store.

The purpose of research. The aim is to improve the accuracy of cutting corners pallets and milling of the lower boards.

Materials and methods research. According to GOST 9557-87 "Poddon Flat Wooden Size 800 × 1200 mm. Tehnycheskye terms "[1], which are international standards for the manufacture of timber pallets used wood (fir, spruce, pine, larch) and hardwood timber (alder, birch, poplar, oak, ash, beech, elm, acacia , maple, sycamore, chestnut). The design of the pallet must comply with HOST9078-84 "Poddonы ploskye. General specifications "[2] and be designed to withstand without residual strain workloads maximum permissible load in the storage, transportation and transshipment.

Wooden pallets details must be without blemish: acute obzelu, germinate, rot, mechanical damage and foreign matter. Knots to 10mm
